

### **Board of Directors Meetings**

Monthly meetings are held in the conference room of the Clubhouse on the second Tuesday of the month at 6:00pm.

Residents are welcome to observe the public portion of meetings and to address the Board during the 'Homeowner Forum' section of the meeting.

### **BOARD MEETING HIGHLIGHTS**

The following actions were taken by the Board of Directors at their meeting held on November 11, 2016

- Approved minutes of October 4, 2016 meeting
- Discussed homeowner comments regarding zoning applications submitted by Van Metre to Loudoun County
- Directed management to strictly enforce the Sign Design Guidelines going forward. Residents in violation will be provided the opportunity for a Hearing in compliance with the HOA's Policies and Procedures Regarding Violation of Governing Documents and the Virginia Property Owners Association Act.
- Denied a request from an owner to purchase common area to install a fence
- Requested additional information on a tunnel painting project
- Tabled the installation of solar panels on the Nature Center
- Tabled the proposed Design Guidelines regarding Geothermal
- Approved the proposed Design Guidelines regarding • Driveways
- Denied the proposed Design Guidelines regarding Gutters and Downspouts
- Approved the proposed Design Guidelines regarding Air Conditioners and Heat Pumps
- Approved the revised proposal from Precision Safe Sidewalks to address severe and more severe risks of sidewalk trip hazards, starting in a section of townhomes
- Approved the 2017 Operating Budget and assessment levels
- Accepted the Annexation Fee offer from Van Metre of \$5,000 per recorded unit for the annexing of section 108
- Approved the removal of 3 posts on a forum thread

### Be a Vigilant Resident

Crime. It's not something anyone likes to talk about, but unfortunately it is around us, even in safe communities such as ours. A crime of opportunity is a crime that is committed without planning when the perpetrator sees that he/she has the chance to commit the act at that moment and seizes it. Such acts have little or no premeditation and include things like breaking into unlocked vehicles or the pocketing of an unattended phone/wallet/purse, and these



have occurred within the community.

Breaking and entering is the criminal act of entering a residence or other enclosed property through the slightest amount of force (even pushing open a door), without authorization. We have received reports of homes that were broken into via the basement door. The sheriff's department has noted that this may be more likely to occur in homes backing to wooded trails where a thief can obtain access to the home without much visibility and slip back onto the trail for a quick getaway. They suspect teenagers to be the culprits, hiding the small contents of the theft in their backpacks inconspicuously.

Unfortunately with the upcoming holiday season, theft of mail/packages and residential burglaries tend to increase as well. The sheriff's department recommends you request signature delivery on all packages being delivered to your home (keep this in mind for friends and family when shipping gifts to their homes). Here are some additional things you can do to help reduce the likelihood of crime in your home:

- Keep all doors and windows locked. If you have an alarm, activate it. If you don't have an alarm, get one. Webcam security has become increasingly popular, and there are a myriad of webcams on the market, such as Nest Cam, Piper, Canary, Simply Safe, and Perch.
- Never leave keys in doors near glass. Hang spare keys out of reach from doors and windows.
- Never leave strollers, bikes, lawn mowers, tools, sporting equipment or any other valuable items sitting unattended around your home.
- Keep your garage door closed. Would-be thieves canvass neighborhoods for bikes, tools, and other valuables stored in your garage. Items may be taken from your garage in broad daylight, or from an open garage after dark. See vigilant, page 8

A response to your application is generally sent within one week of the meeting.

Once the Subcommittee has reached a decision, the results letter will be delivered via email. If an email is not provided, then the results letter will be mailed. Therefore, please check your inbox and junk/spam folders for your results letter or contact the HOA office at 703-729-9704.

### DESIGN GUIDELINE CHANGES

The Modifications Subcommittee has updated the design guidelines for Driveways and Air Conditioners/Heat Pumps.

### Driveways

- Approval is not required for the replacement of an existing, approved driveway as long as the same material and footprint is used.
- Driveways that are widened must be tapered to merge with the existing driveway or the street apron. (Illustration provided on page 7)
- For houses with front-loading garages, the driveway extension should not extend past the front edge of the house. For houses with side loading garages, driveway extensions should not extend past the wall in which the garage doors are located. (*Illustration provided on page 7*)

### Air Conditioner/Heat Pumps

- Extensions of condensation pipes which are above ground and visible may not exceed 3 feet. Extensions used for additional drainage purposes must be buried underground.
- Water flow from condensation pipes must not adversely affect drainage onto neighboring properties.

When using a snow blower, please blow your driveway snow onto your own lawn, not your neighbors, the street or the sidewalk.



- don't provide thieves with additional incentive to break into your home to access these items.
- Never leave your purse: in the cart at the supermarket or department store; on the floor next to your chair; hanging from the back of your chair, or on the chair next to you in restaurants or on public transportation; or in an unattended desk at work.
- Never leave laptops, purses, keys, cameras or other valuable items next to a door or visible from a window.
- Never leave valuables visible in your car. If you must leave them in your car unattended, place them in the trunk before you reach your destination.
- Leave exterior lights on all night. Put lights on a timer. Put inside lights on timers when away.
- Install a peep-hole in your front door, and do not open the door to strangers. Add dead-bolt locks to all doors.
- Get to know your neighbors, so that you can recognize those who don't belong on the block, and form a buddy system with a neighbor to take in mail and papers while you are away.
- If you witness a burglary or other crime in progress, call 911 and report "Crime in Progress." Write down everything you see and keep notes in a safe place. Read your notes to the 911 operator.

Additionally, report all crimes to the sheriff's department. We hear time and time again from residents saying "I don't want to bother the sheriff's department," but the deputies tell us repeatedly that all crimes, large or small, should be reported. Sometimes they can piece information from multiple crimes together in order to find the culprit, and sometimes they are able to locate stolen items and can return to owners if they can match them up. Also, go with your gut feeling. If something doesn't seem right, it probably isn't right. Better to report a suspected issue and have it be a false alarm than to have ignored a sign and have it be missed.

### MONDAY HOLIDAYS ARE FOR NATURE CENTER ADVENTURES!

Grades Kindergarten-5th Grade at the Broadlands Nature Center January 16th: Holiday - Martin Luther King Jr. Day February 20th: Holiday - Presidents' Day May 29th: Holiday - Memorial Day) Program's time: 7:45am-2:45pm

As a new service to the community we are offering full-day Nature Center Adventures on Monday holidays from school. We know everyone doesn't get the day of; and if the kids have a holiday from school it should be fun and memorable.

The programs will be held outdoors as much as possible, dress accordingly. Grades 3rd-5th have the opportunity of doing animal care training and becoming part of our Youth Naturalist program. All participants will take part in animal care, nature learning, scavenger hunts; learning through creating, and games.

Hours for Monday-off child adventures are the same as the school, see above, with options to lengthen if needed.

Price per day is \$50.00 with a reduction of \$40.00 per child if multiple children are enrolled. These programs include all of the materials, but none of the food (send a packed lunch with your child).

The ratio of instructor to participants will never be greater than 1:12, 24 students maximum. Youth Naturalist interns will be present to support animal care training and interactions as well as to facilitate team games.

If you participate in the Direct Debit Program through FirstService Residential, you will not receive a coupon booklet and the 2016 assessments will be automatically deducted from your account.

Owners are encouraged to sign up for the Direct Debit Program through FirstService Residential. Your monthly assessment will be automatically deducted from your bank account during the first week of every month. This eliminates the possibility of a payment being missed or lost in the mail and the Association charging a late fee to your account as a result.

FirstService Residential also accepts major credit cards and e-checks for assessment payments. 

### A Lite Fare Menu to Share with Friends and Family During the Holidays

### Marinated Kale Salad with Apples and Oranges

In a small bowl, whisk together the dressing ingredients. Place the kale in a medium bowl and drizzle the dressing on top. Toss a few times until well coated with the dressing. Let the kale sit for about 10 minutes, tossing often to re-coat with the dressing. Add the remaining ingredients, toss again, divide between two plates and serve. *Communitytable.parade.com* 

#### For Dressing:

- 4 tablespoons canned mandarin orange juice
- 1 tablespoon olive oil
- 1 tablespoon white wine vinegar
- 1/2 teaspoon Dijon mustard
- Salt and pepper, to taste

#### For Salad:

3 to 4 cup finely chopped kale leaves (toss the tough ribs) ½ cup canned mandarin orange slices ½ medium red apple (Gala or Red Delicious), chopped 1 tablespoon raw sunflower seeds

### Cannellini and Escarole Soup with Garlic Oil

In a large saucepan, cook the bacon over moderately high heat until crisp, about 6 minutes. Using a slotted spoon, transfer the bacon to a plate. Pour off all but 2 tablespoons of the fat and return to moderately high heat. Add the escarole, minced garlic and crushed red pepper, season with salt and black pepper. Cook, stirring, until the escarole wilts, about 2 minutes. Meanwhile, in a blender or food processor, puree half of the beans with the chicken stock until smooth. Add the pureed and whole beans, bacon and 1 1/2 cups of water to the saucepan and bring to a boil. Reduce the heat to moderately low and cook until the escarole is tender, about 10 minutes. Meanwhile, in a small skillet, cook the crushed garlic in the oil over moderate heat until golden; discard the garlic. Drizzle the soup with the garlic oil and sprinkle with the Parmesan. *Foodandwine.com* 

- 4 thick slices of bacon cut crosswise into 1/2-inch strips 1 small head of escarole, coarsely chopped
- 4 garlic cloves—1 minced, 3 crushed
- 1/4 teaspoon crushed red pepper

Salt and freshly ground black pepper

Three 15-ounce cans cannellini beans, drained and rinsed

- 2 cups chicken stock or canned low-sodium broth
- 2 tablespoons extra-virgin olive oil
- 2 tablespoons freshly grated Parmesan cheese

### **Dark Chocolate Bread Pudding**

Preheat oven to 325°. Butter a 13x9" baking dish; arrange bread in dish, overlapping as needed to fit. Heat milk, chocolate, sugar, vanilla, and salt in a heatproof bowl set over a saucepan of simmering water (don't let bowl touch water), stirring until chocolate is almost completely melted, about 3 minutes. Remove from heat and stir until chocolate is completely melted (this method prevents chocolate from burning). Let cool. Add eggs one at a time to chocolate mixture, whisking to blend after each addition. Pour over bread, pressing to help bread absorb liquid. Let sit at room temperature until bread is saturated, about 1 hour. Bake uncovered until bread pudding is just set (it will jiggle slightly), 30–35 minutes. Let cool slightly on a wire rack. Serve with whipped cream, if desired. *Bonappetit.com*

### SNOW REMOVAL FAQ'S...

In order to help assist residents with snow removal questions, the Board and Management have prepared the following Frequently Asked Questions. Please contact the HOA office if you have further questions. A list of streets and ownership can be found online at:

### 1. Why are some roads plowed by VDOT and some by the HOA?

The HOA owns and maintains some roads (75 to be exact) within Broadlands, but many roads are public. The public roads belong to the county and are plowed by VDOT. Taxes pay for VDOT to plow, so residents living on public roads need to contact VDOT directly if they feel they are not receiving adequate service. Residents living on private HOA owned streets pay an additional assessment to the HOA to fund private road maintenance, which includes snow and ice services. Residents on VDOT streets do not pay the HOA the additional assessments for private road maintenance.

### 2. Can VDOT plow the HOA owned road?

The HOA would gladly turn all of the private roads over to them. Unfortunately, the county has very specific requirements for roads – such as minimum widths – and VDOT will not accept roads that do not meet their requirements. The HOA does not choose which roads it owns. This is determined when the developer submits the plan to the county - long before construction begins.

### 3. Why are some streets plowed sooner than others?

The crews are assigned maps by their leader. They work on their assigned streets until they are done. With 75 private streets, some roads will be treated first and some will be done last because the plows cannot be on every street at the same time. The crews normally address the main roads first and then work into the secondary roads. You might see a plow drive past your street without stopping. They may be assigned somewhere else, there may be a vehicle blocking access, too many vehicles parked in the way to get the equipment in safely in, or there may be too much snow for their equipment to handle. In blizzard-type storms, snow drifts presents additional challenges - previously cleared roads can become snow-covered again, pulling crews back for additional passes. Whatever the reason, crews will be work to clear your road as quickly and safely as possible.

### 4. Why don't the plows clear the road down to bare pavement?

Vehicles driving on snow compact it down, making it more difficult for the plow blade to clear the surface to the pavement - one reason the government, media, and HOA encourage residents to stay home and off the streets during inclement weather. The HOA does not generally use chemicals in subdivisions. Residents should expect streets to have some compacted snow and ice for a few days, until temperatures allow for melting. Crews will treat certain areas with icemelt e.g. certain hills and intersections, curved roadways, etc. where additional traction is needed to allow safe passage. But thaw/freeze cycles may cause these areas to become covered again. Keep in mind that high winds may cause drifting in some areas - a street may have been plowed only to later be covered again by blowing snow. It can also be difficult for plow blades to scrape down to black pavement, depending on the current conditions (how dry/wet the snow is, how fast it is coming down, how hard the wind is blowing, etc.)

# 5. Why don't the plows clear the entire width of the street, from curb to curb? Plows are often a misunderstood piece of equipment. If you've ever driven a full sized pickup on a crowded street like many of the ones in our community, which can be a challenge on its own, consider what it's like to add a plow blade sticking 4 feet out in front of your vehicle. Even a "small" plow truck can be in excess of 22' long. Operating a large vehicle, manipulating a plow blade from side to side and up and down, and frequently shifting gears is pretty challenging.

Plow blades can push snow off to the side, but they cannot pick it up. When

significant accumulation occurs, the drivers will do everything possible to clear the widest lanes, but they may not be curb to curb. Bear in mind that these trucks can slide on ice and snow covered roads too, so plow drivers exercise extreme caution near parked vehicles, causing owners to have to shovel more to get vehicles out to the road. The contractor widens the roads as much as reasonably possible, but in some of the densely populated areas, there is nowhere to push the snow during extremely high snow fall events. Please park your vehicles off the roads and off to the sides of parking lots whenever possible. Abandoned vehicles can also add to the issue.

### 6. Why can't we use reserves to pay the snow removal bills?

Reserve funds are required to be held for future repairs and replacements of community property and cannot be used for snow removal. Those funds are on hold in reserve to pay for major expenses such as resurfacing HOA roads, re-roofing the community center or replacing pool machinery, not operating expenses.

# 7. Why are the fees for HOA owned streets higher than for residents on VDOT streets? How much of the monthly assessment goes to snow plowing?

For 2017, the budget for snow removal for townhomes is \$54,320. That's \$44.46 per townhome per year (or \$3.74 per month for each of the 1,211 townhomes in the Association). The budget for snow removal for Single Family homes on private streets (SFPS) is \$24,711. That's \$66.61 per SFPS home per year (or \$5.55 per month for each of the 371 SFPS in the Association). The balance of the monthly assessment is for private road maintenance for the repair and repaving of those roads, aprons, curb and gutter, and sidewalks.

### 8. Why don't we budget more for snow removal and increase service?

It's impossible to predict the weather months (or even days) in advance, and snow is a huge variable from year to year. When formulating the budget, the Board uses an average cost of snow removal for *See snow FAQs on page 20*

past years. Inflated amounts can lead to unnecessary increases in assessments, or a surplus of income in the budget. The Association is required to maintain a balanced budget. The Board makes every effort to keep assessments stable while keeping services as high as possible.

### 9. How does our snow contract work?

The Association's contract is "time and materials" and is at a fair and reasonable cost for these services in our area. Each snow event is different and unpredictable, but we are billed only for the time the contractor worked. The Association is fortunate to have a contractor that is solely dedicated to Broadlands and willing to work around the clock. Many associations have crews that are assigned to multiple properties, and their community may not be a priority for that contractor. If you've ever driven down Demott Drive, you've probably seen some of the equipment stored in the Summerbrooke pool parking lot. All of this equipment is stored on site all winter and is dedicated to Broadlands. Additional equipment that is utilized by the contractor for other jobs year round is brought for snow events in order to fully support our needs.

### 10. How do we know we are receiving the best and most qualified plowing service?

Signature Snow and Ice Control (SSIC) has been providing snow plowing services in Broadlands for nearly 20 years. Their rates are extremely competitive and they are familiar with the most efficient and productive ways to plow our streets. They routinely provide Broadlands with seven plow trucks, a tractor, and crews dedicated to clearing our roads and sidewalks as quickly as possible. Additional equipment is brought in as conditions warrant.

### 11. Do crews take breaks? How long do they work between breaks?

Many of the drivers work long hours during winter weather events - often 24 to 36 hours at a time without the opportunity to go home and sleep in a real bed. The goal during heavy storms is for each driver to have a 6 hour break every 24 hours. Sometimes they need breaks more often in order to nap, eat, use the restroom, or touch base with loved ones. It's understandable and recommended that they would take a break once in a while in order to reenergize and safely continue their work. They work day and night, driving slippery roads, dodging parked cars and avoiding hazards to clear the roads. All so that emergency responders can reach residents in the event of a life threatening emergency.

### 12. Can the plows push the snow in such a way as to avoid blocking my driveway?

A plow blade is designed to push snow to the side; it will not pick it up and deposit it elsewhere. As the plow moves along the road, snow is piled up along the side whether that side has a curb, a driveway, or a guardrail. In order to clear a lane quickly, the plows will push snow off to the sides. It can be very frustrating to dig out the driveway only to have the plow leave a new pile. VDOT recommends digging out an area 10 to 15 feet to the right of your driveway (viewed from the street), giving the excess snow a place to go, which may help to minimize the plow pile at the end of your driveway. Obviously this is difficult to do in some of the densely populated areas where driveways are side by side.

### 13. Who is responsible for clearing around the fire hydrants?

On HOA owned streets, our contractor marks all of the hydrants using wooden stakes with blue tape on them. This way they can return after the snow subsided and the roads are clear to dig them out to make them accessible for fire trucks. On VDOT streets, it is the residents' responsibility to mark and dig out the hydrants.

### 14. Where should I put the snow from my driveway/sidewalk/parking space if not in the street?

The HOA and VDOT ask that you do everything possible to avoid shoveling snow into the street as it creates road blocks for your neighbors and adds to the snow volume that the plows have to move out of the way. Try to pile the snow in your yard or find some common area open space (turf, not roadway) to place the snow.

15. Why does the HOA mark the main roads with the orange snow stakes? Why doesn't it mark the private roads? A few years ago, the HOA invested in the snow markers in order to identify the edges of the roads on the main roads (Claiborne/ Waxpool/Truro Parish/BroadlandsBlvd). Although these are VDOT roads, the association has an easement to maintain the turf on the medians and right of ways on these roads. Therefore, the HOA has to pay for turf repairs when they happen. These stakes assist the plows for two reasons. For one thing, the equipment that keeps these main roads clear are larger commercial grade trucks that sit several feet higher off the ground than a regular pickup truck. That makes it that much harder to see the edges of the road. Additionally, when VDOT installed the curb on these roads, they rounded the edges in order to save concrete. This does not define the edge of the road in the same way that a square concrete curb does, and it's much easier for the plows to jump the curb and shave off large sections of turf in doing so. On the HOA roads, the plow equipment is generally smaller so the drivers can see a bit easier. Also, most, if not all of the HOA roads have square curbs, making it slightly harder for the plow to jump the curb and damage the turf. While the HOA has observed turf damage on main roads following storms, the damage is significantly lower than it would be had the stakes been absent. The stakes typically get installed in November before the ground freezes, so they can be driven deep enough to be stable. They do occasionally get broken, stolen, or vandalized, and are reinstalled or replaced as necessary.

### 5 GIFTS THAT MIGHT LAND YOU IN THE ER

Hover boards: The motorized boards look easy and fun – I just stand on it! - but they take balance and practice for safe use. Because they are often used indoors, without protective equipment or helmets, wristfractures and concussions, from falling forward or back, are common.

**Magnets**: For toddlers any magnet small enough to fit in the mouth is a no. Even in older children and adults, games, jewelry and crafts that contain small magnets pose a big risk. Accidentally swallowing a magnet is an automatic trip to the ER.

Batteries: Like magnets, the button batteries that come with many electronic gifts are small, shiny, and appealing. If swallowed, batteries can get caught half way down the throat or in the stomach lining and because batteries are chemically caustic, they can erode through tissue or blood vessels.

**Trampolines and bouncy houses**: Trampolines have long been known for their risks, but the popularity of indoor trampolines and bouncy houses have caused a spike in broken bones, head injuries and abdominal trauma. Children don't understand the danger of bumping into each other and indoor use ups the risk that kids can fall into or onto hard objects around them.

Toy guns and plastic swords: These type of toys annually make it onto America's worst toys list by WATCH, the World Against Toys Causing Harm group, because of the risk of blunt force trauma and the violent games they encourage. Even soft darts are a danger to eyes.




