The School Board of Loudoun County, Virginia (the "Applicant") hereby gives notice that the above-referenced application will be heard at a public hearing before the Loudoun County Board of Supervisors on the evening of Wednesday, January 10, 2018 at 6:00 p.m., in the Board of Supervisors Meeting Room, County Government Center, 1 Harrison Street, S.E., Leesburg, Virginia.

Please be advised that you may receive additional notices, including CERTIFIED NOTICES, for this hearing. THE VIRGINIA STATE CODE and THE LOUDOUN COUNTY ZONING ORDINANCE REQUIRE CERTIFIED NOTICE MAILINGS TO CERTAIN PROPERTIES.

The Applicant has submitted an application for Minor Special Exception (SPMI) approval to allow an alternate offsite storm water management facility on a parcel adjacent to the proposed ES-31 Dulles North Elementary School (CMPT 2017-0006). The SPMI application is the subject of the January 10, 2018 public hearing. The Commission Permit was approved by the Planning Commission on November 28, 2017. The Board of Supervisors will consider the Commission Permit to either ratify or overrule the Planning Commission's decision. The subject property is zoned R-1 (Single-Family Residential) and is partially located within the FOD (Floodplain Overlay District). This application is subject to the Revised 1993 Zoning Ordinance and the proposed uses require a Commission Permit in accordance with Section 6-1101. The subject property is approximately 2.5 acres for the storm water management facility and 13.5 acres for the elementary school. Both are located on the east side of Belmont Ridge Road (Route 659), north of Waxpool Road (900), and south of Truro Parish Drive (Route 2119), in the Broad Run Election District.
