Reserve Funding - What are Reserves?

There can be a lot of confusion about HOA's and what they do with assessments that are collected from the homeowners. Particularly with a very large association like Broadlands, it can be easy to get confused by its many moving parts. One of the most misunderstood parts of a budget is reserves. So, what are they?

Reserve funds are designated sums of money set aside for future expenses such as building, road, and trail repairs or replacements. Reserve funds ensure that all owners in an association help contribute to the future repair and replacement of items they have enjoyed during the duration of their ownership. Reserve funds, unlike operating funds, pay for the major repairs and replacements of the common elements. While the annual operating funds might pay for the annual replenishment of safety surfacing at the tot lots, reserve funds pay for the replacement of the entire structure every 25 years. Operating funds pay for the replacement of a failed belt on a pool pump, but reserve funds pay for the replacement of the entire motor every ten years. Operating funds pay for routine maintenance for HVAC or plumbing in community buildings, but reserve funds replace the HVAC system every 15 years and the roof every 30 years. Operating funds pay to replace the bulbs in the path and streetlights, but reserve funds pay to replace the entire fixture every 40 years. Reserve funds protect the stability of your association's finances from naturally irregular, yet predictable, future expenditures for the replacement of reserve components.

An HOA needs to have a healthy reserve fund to prevent unexpected financial burdens on homeowners. An adequately funded reserve account helps alleviate the need for special assessments for major maintenance and replacement of common property. Special assessments can be viewed as red flags by lenders and prospective buyers as they can be indicative of insufficient budgeting or unsuitable caps on assessments. HOA's must disclose special assessments to prospective homebuyers in the resale disclosure packages, the contents of which are dictated by state statute. Special assessments are sometimes unavoidable, and Broadlands did implement a special assessment in 2010 following an unprecedented winter with extraordinary expenses relating to snow services as well as a real estate market crash which caused an unexpected rise in delinquent owners.

The size of the reserve fund is determined by an engineering study known as a reserve study, where an outside professional assesses the current condition and projected future costs of common area assets.

In Virginia, state law requires that reserve studies be updated at least once every five years. Broadlands hires an independent engineer to analyze the inventory of all items owned by the association, assess the condition of these items, estimate the remaining economic life and replacement cost of each asset, and develop a financial plan for the major repair and replacements of said items over the next forty years.

The association will be updating our reserve study this year, incorporating common elements like roads and trails in new sections of Demott & Silver and Hillside, as well as new play equipment in Overland Park and Village Drive. A copy of the 2020 reserve study can be found in the online portal FirstService Connect and the new one will be uploaded there once it is complete. If you're unfamiliar with Connect, please check out <https://broadlands.connectresident.com/> and set up your online account. This will give you access to your account history, the financial records of the association such as the monthly income and expense statements, and other forms and the legal documents of the association. Having a solid reserve fund allows the board to maintain property values and provide a comfortable living experience for all homeowners. Reserve contributions in 2024 total \$882,430 of our annual budget. Contributions are made monthly into designated reserve accounts which are overseen by a wealth advisor and invested into laddered CD's that are FDIC insured. Once designated as such, reserve funds cannot be used for any other purpose.

Broadlands was also fortunate to receive funds from the developer in the form of annexation fees, which have funded capital projects such as the solar array, the community center recreation pool, and the HOA office renovation. Modifications Information

Per Article 7, Section 7.5 (a) Additions, Alterations, or Improvements by the Owners - "No person shall make any addition, alteration, or improvement in or to any Lot or any portion of the Property... which is visible from the exterior of the Lot or such portion of the Property, without the prior written consent of the Covenants Committee."

If you are unsure if approval is required for your project, contact Robin Crews, Modifications/Resale Manager at rcrews@broadlandshoa.com or 703-520-9902. The Committee meets virtually at 7:00pm on the first and third Wednesdays of the month March-October and the third week of the month November-February. *If you wish to attend a meeting, contact Robin Crews, rcrews@broadlandshoa.com.* Applications must be submitted by noon on the Wednesday before the meeting by emailing them to rcrews@broadlandshoa.com or delivering them to the Nature Center drop box at 21907 Claiborne Parkway.

Please review the Design Guidelines and submission requirements at broadlandshoa.org/design-guidelines. Failure to include all required information will delay review of your application. Once the Committee has reached a decision, the results will be delivered via email. If an email address is not provided, results will be mailed. Emails will be sent from no-reply@smartwebs365.com should you wish to add this email address to your contact list to ensure prompt delivery. Please check your inbox and junk/spam folders or contact the HOA office at 703-520-9902 if you have not received your results within 10 days following the meeting.

Are You Selling Your Home?

Save yourself time and aggravation by ensuring you have approved applications for all exterior changes or additions made on your property before listing your home. Walk around your home and look for any maintenance violations such as siding repair, exterior trim maintenance, deck/fence repair, fresh coat of paint or stain maintenance, mailbox unit repair, removal of any mildew, screen window repair or roof repair. Refer to your property plat to locate your property lines because you may have accidentally placed something in the common area that will need to be removed before settlement.

When you sell your home, you are required to request a resale disclosure package for the buyer.

Once the request has been executed, it notifies the HOA to come to your property to perform a resale inspection. The inspectors will look for any structures that have not been approved by the Modifications Subcommittee, that are not in compliance, and for maintenance violations. The results of the resale inspection are embedded in the resale disclosure package that is provided for the buyer. It is the seller's responsibility to rectify all violations found on the property before settlement of the home. If any violations are not rectified before settlement, then the new owner will be responsible.

There are submission procedures on the HOA website, broadlandshoa.org, to help guide you through the application process. Please refer to the online Design Guidelines for detailed information.

The Design Guidelines provide a framework to maintain design quality and encourage consistency throughout the community. Attention Tenants with Pool Passes

If your lease is expiring during May, June, July, or August and you plan to renew or extend your lease, please provide an updated Absentee Owner Statement (AOS) signed by the property owner and a copy of the new lease or lease extension. This will allow us to update our records, including pool pass accounts. Tenant pool passes will expire at the end of the lease term unless there is an updated AOS and lease/lease extension on file in our office.

To ensure pool passes remain valid for the entire pool season, please submit the updated documents as soon as possible. You can do so by emailing the AOS and lease/lease extension to info@broadlandshoa.com. You can find the AOS form at broadlandshoa.org/tenant-information. Please allow 3 business days for processing of all submissions.

Please note that lifeguards and pool assistants cannot provide this service at the pools. New tenants will need to submit an AOS and lease and register for virtual pool passes at broadlandshoa.org/amenities/pool. Please allow 3 business days for processing of all submissions. Access to the pools will NOT be granted until proof of residency and photos have been submitted.

Modification Guidelines

Before you make any modification change or addition to the exterior of your home, an application is required for the Modifications Subcommittee to review. Please refer to Design Guidelines (Modifications), broadlandshoa.org/for-residents/design-guidelines/, for more details and submission requirements.

Remember to Weed Your Yards and Trim Your Trees

Per the Lawn and Yard Maintenance Resolution 6.11.13 found on broadlandshoa.org/rules-and-regulations, lot owners and residents shall keep their properties free of excessive weeds, overgrown or unsightly shrubbery or other plant growth. Lot owners and residents shall undertake any weeding and mulching of planted beds and pruning of shrubbery and trees which is necessary to keep a proper, neat and clean appearance of the Lot.

An owner of a lot that borders a sidewalk shall ensure that any trees which overhang the sidewalk are trimmed to provide a minimum height of eight (8) feet, measured above the sidewalk level, free of obstruction. No trees with a diameter of more than four inches and measuring two feet above ground level shall be removed without the express written authorization. Lot owners and residents shall remove any and all dead plants and shrubs from their Lots.

If you have questions regarding weeding and pruning maintenance, contact the covenants team at covenants@broadlandshoa.com or to request a reasonable extension to rectify the issue.

Patriot Disposal Trash, Recycling, and Yard Waste Collection Schedule

Trash, Recycling, and Yard Waste Collection:

- Place toters out the night before collection day after 6:00pm or before 6:00am the day of pick up.
- Containers should be out of sight by 9:00am on the day following collection.

Trash Collection:

- Trash pick up days are Mondays and Thursdays.

Recycling Collection:

- Recycling pick up day is Thursdays.
- Recyclable materials can be co-mingled.
- Plastic bags CANNOT be recycled. The Nature Center collects bags for proper recycling. Visit broadlandshoa.org, click on RESIDENTS then click on TRASH & RECYCLING for more information.
- Scrap metal – Please call Patriot Disposal to set pick-up day 1-703-257-7100: i.e. foil, pie tins, trays, pots and pans, small car parts, grills, bicycles, swings, etc.

Yard Waste Collection:

- Yard Waste Collection occurs on Mondays from March 1st through December 24th.
- During January & February, yard debris (leaves, grass clippings, brush) may be mixed with trash. Yard waste may not be mixed with recycling.
- Grass clippings and leaves must be set out for pickup in lawn paper bags or in a bin.
- Brush must be less than 4 inches in diameter, cut into 4 foot lengths, and tied in small bundles or bagged.
- Food waste mixed in with yard waste will be accepted, as it can be composted.

Special Pick-ups:

- Please contact Patriot Disposal, 1-703-257-7100 or customerservice@patriotdisposalervices.com, to arrange pickup of special and/or bulk items.
- Special items will be collected weekly. Some items may incur an additional charge.
- Special items include appliances, mid to large furniture and other large items.

Trash Totes/Cans Notice:

- *If trash totes/cans are stored in public view outside of these times, you may receive violation notices and, if it continues, you may be called to a Hearing before the Board of Directors.*



- Siding
- Basement walk-ups & surrounding areas
- Front stairs, handrails & leadwalks
- Decks & fences
- Patios

DAMAGED EXTERIOR TRIM/ROTTING WOOD

- Trim around doors, windows & garage
- Roof line trim & wrap
- Porches

PAINT & STAIN (application is required for color/stain changes)

- Trim color should be consistent on the entire home
- Shutters, front doors, railings
- Color application should be uniform & consistent
- Exterior light poles (Should be painted black)

REPAIR & REPLACE

- Falling/damaged boards & lattice on decks/fences
- Fence/gate: replace warped, cracked, missing & splintered boards

HOME EXTERIOR

- Missing Shutters
- Loose or missing siding & roof trim
- Crooked or missing light fixtures
- Trash & recycling containers should be stored out of sight
- Garage doors should be in good condition; no dents

LANDSCAPING

- Neat appearance of lawn & free of weeds
- Landscape beds free of weeds, fresh mulch applied

Ask Dr. Mike

Dr. Mike,

Our 18-year-old daughter who is a senior in high school, is addicted to her phone, and we don't know what to do. The phone is always in her hand, and even though my husband and I don't disapprove of most of what she's doing with the phone, we also think she's on it way too much. We've tried to set limits, we've taken it away, we've talked to her, but nothing has worked. In fact, everything we've tried so far has led to tension, disagreements or really bad fights. Her position is that she gets great grades, she plays a team sport, she has a part-time job, she has an active social life, and she helps out around the house, so we should just leave her be. She's correct that she's doing great and we're proud of her, but we're still worried that she over relies on her phone, and it's turned into a bad habit. How is she going to do well in college if she's always on her phone? Life was simpler and better when we were growing up and technology wasn't the driving force for everything. Your help is appreciated.

Worried Parents in Loudoun

Dear Worried parents in Loudoun,

Based on what you've written, it doesn't seem that your daughter is addicted to her smartphone. Perhaps she uses it compulsively at times, but I'm not so sure her phone use merits serious changes or parental intervention. If your daughter, as you shared, does well academically, has a part-time job, plays a team sport, has a solid social life, and helps out around the house, then she is arguably succeeding, and she seems to have achieved impressive balance in her life at a young age – not an easy feat for so many teens.

For starters, I encourage you to reflect on the ways in which your own biases or beliefs may be impacting your negative opinion of your daughter's phone use: is it possible that her phone use worries you as much as it does because of your own discomfort with, or dislike for, technology? Certainly, every generation is proud of their time, and it's common to romanticize our childhoods, but to believe that life was simpler and better when technology was less available or less pervasive probably isn't completely accurate. Sure, some aspects of our lives were easier before smartphones, but smartphones also allow us to do so much.

I also think, as parents, you need to give your daughter the space she needs to figure out her relationship with technology. You write that you're worried she will not do well in college if she's always on her phone, but you also write that she's

on her phone too much for your comfort level now and doing well. Senior year of high school is the perfect time for you to afford your daughter with age-appropriate opportunities to increase her independence and autonomy in the world in preparation for college life.

I also recommend that you sit down again with your daughter to have a conversation about this topic. But this time, make the focus of the conversation on your concerns and not your position. It's not that your daughter's wrong and you're right, it's more about talking things out altogether and getting to a better place. Letting your daughter know that you will work on respecting how she chooses to engage with technology, alongside asking her to respect your basic parental expectations (e.g., your daughter taking a break from her phone during family meals or at other times), is fine to assert and compromise on.

If, however, your daughter's phone use continues to be a problem for you as parents over time, I recommend that you seek out the help of a family therapist.


Dr. Mike,

My husband and I have done very well financially. Neither of us came from money or inherited anything substantial, but we've worked hard and have acquired quite a bit of wealth. For context, we live in a \$12,000,000 house, and we have other properties, several businesses and a large amount of money saved and invested. My husband is adamant that we should not leave a dime to our kids, and he believes they should instead work for everything like we did. While I agree with him that our children need to find their own way in life and earn as they go, I also don't think it's a terrible thing to help your adult kids or to leave them an inheritance if you can. Our financial advisor agrees with me, and he pointed out in our last meeting several very reasonable ways we can leave our adult children money without making their lives too easy. My husband became so upset in that meeting that he stormed out and threatened to divorce me if I didn't side with him to leave our children absolutely nothing. I was humiliated then and am now confused about so much, including my marriage. What's so bad about leaving our adult children our money once we've passed? Isn't that what loving parents do if they're able to? What's crazy is that we have great kids who we haven't spoiled and who work hard and are caring to others. BROADLANDS POOLS REGISTRATION

Pool season runs May 25th – September 2nd!

If you have already registered for your pool passes, then you're good to go. If not, please follow the instructions to set up virtual passes for your household. You only need to register once, and your passes will remain active until your residency status changes.

STEP 1 – CREATE HOUSEHOLD ACCOUNT: Go to Cellbadge.com/Broadlands/register and under **Initial Add Request**, enter the information as a primary resident to create your master household account. **Please enter street number and name only, no suffix (i.e., Ct, Court, Ter, Terrace, etc.).** Your add request will be forwarded to HOA staff who will validate your residency and account status. Please allow up to 3 business days for the initial approval to be processed. Once validated, you will receive a text/email indicating that your registration has been added but will remain pending until all 4 steps have been completed.

STEP 2 – ACQUIRE PIN: After you have received a text/email that your registration has been added, please return to the same registration page, and follow the instructions under **Enter or Update Household Members**. Enter your credentials to get your unique PIN via text/email to continue the process.

STEP 3 – ADD HOUSEHOLD MEMBERS: Enter PIN to access the **Household Members** page to add all household members, ages 5 and older. Be sure to select the appropriate “**Relation**” category when adding members:

- Owners select “Owner-xxx” for ALL household members regardless of age.
- Tenants select “Tenant-xxx” for ALL household members if the owner does not live on the property. Must have AOS/Lease on file.
- Apartment Renters select “Apartment-xxx” for all household members. Must **pay first** at broadlandshoa.org/pool.
- Nannies/Long-Term guests, select “Other-xxx” as applicable. Must **pay first** at broadlandshoa.org/pool.

Once finished, check the box to verify you have agreed to the facility terms and click **Complete Registration**. Upon approval (within 3 business days), you will receive a text/email indicating that **your Broadlands HOA registration has been accepted**, however, you must complete STEP 4 (pictures) to gain access to the pools.

STEP 4 – PICTURES: Email pictures of all household members aged 5 & up (adults must provide proof of residency):

- Email an ***acceptable** photo (jpg or png format) of each member in your household to pools@broadlandshoa.com. Copies of driver's licenses should be used for 18+ members. Recent copies of headshots may be used for children under 18.
- Subject line of the email must be written as: “**pool photos – registered lastname**” (i.e. pool photos – Smith)
- Save and attach each photo separately to your email using the naming convention: “**address.firstname**” (i.e. 42001Ridgeway.Susan).
- All member names must correspond with registered names in your Cellbadge pool account to allow for proper import. Pictures will be processed within 3 business days.

*What are **acceptable** photos and adult requirements?

- Adults 18 and over are **required** to show proof of residency with a **copy of a driver's license** showing the picture, address, name, and date of birth. For security reasons, all other information can be crossed off. If the ID does not reflect the registered address, then settlement papers, utility bills, or a change of address card may be emailed.
- For children aged 5 and older, please email a **current** headshot or ID. Children aged 4 and under do not require photos.

-----ADDITIONAL INFORMATION-----

ACCESSING THE POOL: After photos are added and you receive a confirmation email, access to our pools is simple since no physical pass is required – just check in with the lifeguard by providing your name or address and they will be able to access your “**virtual ID card**” in the system to allow entrance. **Once registered, no further action is needed in future pool seasons.**

GUEST VISITS: 10 guest visits will be added to your household account each year at no charge. Additional guest visits can be purchased through our website at broadlandshoa.org/pool. Visits do not roll over to the next season. Only two (2) guests per member are permitted or a maximum of six (6) per household at a time.

TENANTS: You must have a **current Absentee Owner Statement (AOS)** and **lease** on file with the HOA before registering. Please see the information on our website under broadlandshoa.org/tenant-information.

APARTMENTS: Tenants of The Arbors and Van Metre Apartments must **purchase a household pool membership before registering** at broadlandshoa.org/pool-information.

public school, they drive used and very average cars, they do well at school and have jobs, they attend church and volunteer, so I don't get any of this. Our oldest son just got accepted to a top university in the country based solely off of his hard work and grades. I don't want a divorce, but it seems this is the hill my husband wants our marriage to die on if I don't fully comply with him. Please help.

Upset in Loudoun

Dear Upset in Loudoun,

While it's admirable that your husband wants your children to make their own way in life, his extreme position to leave them absolutely nothing (when your family has so much) and to threaten divorce if you defy him, is concerning. Money means different things to people, and achieving wealth is determined by a myriad of factors – intelligence, overcoming a difficult upbringing or adversities, talent, ego, status, luck, opportunities, etc. It's not clear to me what personal wealth means to your husband,

but based on what you've shared, I assume his relationship with money is complex.
